- shape clothes using reinforcing materials, perform inter-operational and final ironing; control separate parts and components of clothes products and control finished products;
- assess quality of the unfinished and finished products, assemble clothes products;
- ensure occupational safety and health at work, including fire prevention and stand out for quality of the work and products.

The graduate is employed in performing specific work in the production of clothes in large, medium and small clothing
